



- 1. The team recently undertook a search for clauses related to tax payments across all of their contracts in the Middle East. The task, which would have previously taken the team hours of manual search through each contract, could be performed in seconds with Luminance's Clause Summary widget.
- 2. A member of the executive team urgently needed to understand the potential implications of newly imposed international sanctions on a project contract portfolio in the Middle East. They estimated the exercise would take the legal team weeks to finalise and report back on.
